



## APPEALS NOTED

(June 2023)

### FEDERAL COURT OF APPEAL

*Montréal (City) v. Old Port of Montréal Corporation Inc.*, 2021 FC 806, [2021] 4 F.C.R. 154, has been affirmed on appeal (A-258-21, 2023 FCA 126). The reasons for judgment, handed down June 5, 2023, will be published in the *Federal Courts Reports*.
